This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

Use of this website by you constitutes acceptance by you of this privacy policy ("Privacy Policy"). If you do not wish to accept this Privacy Policy, please do not leave any personal information.

#### Purpose

The purpose of this Privacy Policy is:

- to assure you that we recognise and fully respect the privacy and personal data of the visitors to this website; and
- to explain what personal information we collect from this website, from emails you have sent us and through any paper forms you have completed and how we ensure its best protection.

This Privacy Policy governs this website at www.octopus-thombury.co.uk (referred to in this Privacy Policy as the "Website") as well as any data we already hold about you. Other sites to which the Website may be linked are not covered by this Privacy Policy.

#### Data protection

Octopus Drama Group complies with the Data Protection Act 1998 (the "Act"). For the purposes of the Act, Octopus Drama Group is the data controller and sole owner of the personal data collected on the Website. We also comply with the General Data Protection Regulation ("GDPR").

Octopus Drama Group does not sell, share or transfer your information except as set out in this Privacy Policy.

Unfortunately, the transmission of information via the internet is not completely secure and although we will do our best to protect your personal data, we cannot guarantee the security of your data transmitted to the Website; any transmission is at your own risk. Once we have received your information, we will use strict procedures and security features to try to prevent unauthorised access.

The Act gives you the right to access details that we hold about you. Your right of access can be exercised in accordance with the Act.

GDPR ensures you always have the right to ask whether or not we hold information about you. And if we do, what the information is, why we're holding it and the ways it's being used. You're also entitled to a copy of the information. We always want the information we hold to be up to date and accurate. You have the right to ask us to erase or delete information where you consider there is no longer any justification for us holding it.

#### Information we may collect from you
